- 3. Any Visually handicapped (VH) candidate/candidate whose writing speed is affected by cerebral palsy, if he/she wishes, may get the assistance of SCRIBE. There is no restriction regarding age, educational qualification or marks secured in any examination for the SCRIBE.
- 4. A separate call-letter will be issued to the SCRIBE. The call letter of the SCRIBE will be issued from 27/01/2015 to 07/02/2015 from 10.00 hrs. to 16.30 hrs. from the office of RRC-ER/Kolkata. In addition to that, the call letters for the SCRIBE will be issued in the date and time indicated for the issue of duplicate call letter mentioned in paragraph 2 above. The call letter will be collected by the SCRIBE himself after producing proper photo-identity card. The candidate who is to be assisted by the SCRIBE should also be present along with the SCRIBE in the office of RRC-ER for issue of call letter for the SCRIBE.
- 5. Carrying of mobile phone, blue tooth or any other electronic gadget is strictly prohibited by the candidate. This is mentioned in the call letter itself.
