**Sub: Cancellation Of Candidature under CEN RRC-01/2019**

Following the multiple rounds of Document Verification (DV), re-check of documents, and Medical Examinations conducted under **CEN RRC-01/2019** between February 2023 and November 2024, several candidates were placed in a "Pending" status. This was due to identified lacunae such as missing documentation, incomplete medical reports, or the requirement for credential re-check of documents.

Railway Recruitment Cell provided below mentioned twenty-five candidates with ample opportunities to resolve these issues. However, the individuals listed below have failed to submit the required documents, complete their medical examinations, or report for the re-check of documents within the stipulated deadlines.

Consequently, it has been decided to cancel the candidature of the below-mentioned **25 (twenty-five) candidates** with immediate effect. Railway Recruitment Cell (RRC) will not entertain any further queries, individual representations, or correspondence regarding this matter.
