Scouts & Guides Quota (Open Advertisement) Recruitment. **Notification No: RRC/ER/ Scouts & Guides Quota /2025-2026 (Open Advertisement)**

Final Status of Applications Based on the First and Final Scrutiny Report of the Scrutiny Committee

1. An important notice regarding the status of applications was earlier published on the official website of RRC/ER on 13/10/2025, based on the **1st Scrutiny Report** of online applications received against the Scouts & Guides Quota (Open Advt.)/2025-26 recruitment for **Erstwhile Group ‘D’ (Level-1)** and **Group ‘C’ (Level-2)**.
2. Thereafter, a 2nd and final chance was accorded only to those candidates who were marked as **Rejected** or **Provisionally Eligible (with remarks)**. A total of **69 Rejected** and **45 Provisionally Eligible (with remarks)** applicants for Erstwhile Group ‘D’ (Level-1), and **27 Rejected** and **37 Provisionally Eligible (with remarks)** applicants for Group ‘C’ (Level-2), were extended this opportunity.
3. Subsequently, **49 Rejected** and **36 Provisionally Eligible (with remarks)** applicants for **Erstwhile Group ‘D’ (Level-1)** and **20 Rejected** and **27 Provisionally Eligible (with remarks)** applicants for **Group ‘C’ (Level-2)** resubmitted their documents, which were forwarded for final scrutiny and for taking a **final decision** regarding the eligibility or ineligibility for resubmitted applications.
4. Following this, the **Final scrutiny** of the above-mentioned resubmitted applications has been completed for both **Erstwhile Group ‘D’ (Level-1)** and **Group ‘C’ (Level-2)** in accordance with existing rules and guidelines.
5. Based on the combined findings of the **First and Final Scrutiny Reports, comprehensive and final** status-wise lists have been prepared separately for Erstwhile Group ‘D’ (Level-1) and Group ‘C’ (Level-2) posts, indicating the final status of each application as either Rejected or Provisionally Eligible.
6. Finally rejected applicants may check the final status of their applications along with the respective rejection codes and remarks in “**Annexure-A**” for Erstwhile Group ‘D’ (Level-1) and “**Annexure-C**” for Group ‘C’ (Level-2). Similarly, provisionally eligible applicants may check their final status and remarks in “**Annexure-B**” for Erstwhile Group ‘D’ (Level-1) and “**Annexure-D**” for Group ‘C’ (Level-2).

Provisionally eligible candidates having remarks must comply with the instructions mentioned therein and also keep the documents ready as per the shortcomings shown in the remarks, to produce at further stage of recruitment (if qualified). Applications without any remark are denoted as “N/A”.
9. All **Provisionally Eligible** candidates are advised to keep all the requisite documents ready and produce them at the time of Document Verification (if qualify for Document Verification). Failure to do so may result in cancellation of their candidature without any further notice.
10. Further, all **Provisionally Eligible** candidates are hereby advised to regularly visit the official website of RRC/ER (www.rrcer.org) for further updates, notices, and instructions regarding the subsequent stages of the recruitment process.
11. All candidates whose applications have been marked as **"Finally Rejected"** are hereby informed that they are not eligible to participate in any further stages of the examination process for this recruitment cycle. No further correspondence or representation in this regard shall be entertained.
12. All **Provisionally Eligible** applicants may note that if their documents are found faulty or inadequate at any stage of the recruitment process, their candidature may be liable to be cancelled without any further notice.
