

CORRIGENDUM-CUM-IMPORTANT NOTICE

Sub: Corrigendum to Para 3.0 of the Notification and Re-opening of Online Application Window for Scouts & Guides Quota Recruitment for Erstwhile Group 'D' (Level-1) Posts for Candidates Possessing only **“ITI/Equivalent/NAC granted by NCVT”** Qualification (Excluding 10th pass)

In reference to **Notification No. RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement)** issued on **02.07.2025**, the following corrections are hereby notified regarding the Essential Educational Qualification for Level-1 (Erstwhile Group 'D') posts as mentioned in Para 3.0 of the notification. This corrigendum supersedes the earlier provisions related to the educational qualification prescribed for the said posts.

Corrigendum in Para 3.0 of the Notification No: RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement):

Category	Mentioned Qualification in the Notification dt.02/07/2025	Revised Qualification
Level – 1 (Erstwhile Group 'D')	10th pass from Government recognized Board OR 10th pass from Government recognized Board plus ITI/National Apprenticeship Certificate (NAC) approved by NCVT	10th Pass OR ITI OR Equivalent OR National Apprenticeship Certificate (NAC) granted by NCVT

- **All other required qualifications, including the Scouts & Guides Qualifications for Erstwhile Group 'D' (Level-1) posts, shall remain unchanged as specified in the original Notification.**

Re-opening of Online Application Window for Candidates Possessing only “ITI/Equivalent/NAC granted by NCVT” Qualification, (Excluding 10th Pass)

In view of the above modification, and in order to ensure fairness and compliance, the Administration has decided to re-open the online application window exclusively for **15 days** for candidates possessing the qualification only **“ITI/Equivalent/NAC granted by NCVT” (Excluding 10th Pass)**.

1. The online application link will remain active between **05/12/2025 (10:00 Hrs.) to 19/12/2025 (18:00 Hrs.)** on official website of RRC/ER.
2. **ONLY** candidates whose essential qualification is **“ITI/Equivalent/NAC granted by NCVT” (Excluding 10th Pass)** are permitted to apply during this window.
3. **Candidates who have already applied earlier with:**
 - 10th Pass, OR
 - 10th Pass + ITI, OR
 - 10th Pass + Equivalent, OR
 - 10th Pass + NAC Qualification need NOT apply again. Their earlier applications remain valid.
4. Duplicate or multiple applications will be liable to be rejected.

Important Instructions to Candidates

1. **Candidates must ensure that:**
 - The ITI trade is **approved by NCVT/SCVT and NAC granted by NCVT**.
 - The certificate is valid, uploaded clearly and all details entered match exactly with the uploaded documents.
2. Applications submitted by candidates who do NOT possess “**ITI/Equivalent/NAC granted by NCVT**” (**Excluding 10th Pass**) qualification will be rejected without any further notice.
3. Candidates who already possess the 10th (Matriculation) qualification must **NOT** apply during this window, as they were already provided the opportunity to apply during the earlier online application period from 14/07/2025 to 13/08/2025. Any re-application or fresh application submitted by candidates holding the 10th qualification will be treated as invalid and shall be rejected without further notice.
4. The cut-off date for certificates, educational qualifications, and Scouts & Guides qualifications will be the closing date of the previous online application against **Notification No. RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement)** issued on **02.07.2025** and subsequent corrigendum, i.e., 13.08.2025. As per the Employment Notification, the last date was initially mentioned as 08.08.2025, which was subsequently modified to 13.08.2025 vide Notice No. RRC/ER/Scouts & Guides Quota/2025-26 (Open Advt.) (392) dated 08.07.2025, uploaded on the official website of RRC/ER.
5. No further opportunity will be provided after closure of this 15-day window.
6. This corrigendum forms an integral part of the original notification RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement). ***All other terms and conditions remain unchanged.***
7. The Railway Administration reserves the right to reject applications that do not comply strictly with this corrigendum and instructions issued herewith. Except for modification in the minimum educational qualification of Erstwhile Group ‘D’ (Level-1) candidates, all other terms and condition of **Notification No. RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement)** dated: **02.07.2025** remain unchanged.
8. Candidates are strictly advised to furnish correct and complete information while submitting the online application. Any suppression of facts, concealment of higher or lower qualifications, misrepresentation, or submission of false information at any stage of the recruitment process will lead to immediate rejection of the application. If such discrepancy is detected after appointment, the candidature/appointment is liable to be cancelled/terminated without any prior notice. The decision of the Railway Administration/RRC shall be final and binding in this regard.
