1. **Scrutiny** of online applications received against the Sports Quota (Open Advt.)/ 2025-26 recruitment for **Group ‘C’, Level-4/Level-5 (7th CPC) GP Rs.2400/2800 (6th CPC), Group ‘C’ Level-2/Level-3 (7th CPC) GP Rs.1900/2000 (6th CPC) and Erstwhile Group ‘D’ Level-1 (7th CPC) GP Rs.1800/ (6th CPC)** has been completed in accordance with existing rules and guidelines.
2.  6. All applicants must strictly comply with the guidelines laid down in Notification No. RRC/ER/Sports Quota/(Open Advertisement)/ 2025-26.
 7. It has been observed that some candidates have either not submitted proper education -related documents/certificates or have some discrepancy in the uploaded documents/certificates. Accordingly, candidates who have been rejected with **Rejection Code-4** are hereby requested to resubmit their documents/certificates in compliance with **Para 4** of this notification. As per para **13) III (k)** of the notification, "Certificates in language other than English or Hindi should be accompanied by an attested translation in English/Hindi.
 8. It has been observed that some candidates have either not submitted proper sports - related documents/certificates or have some discrepancy in the uploaded documents/certificates. Accordingly, candidates who have been rejected with **Rejection Code-5** are hereby requested to resubmit their documents/certificates in compliance with **Para 6, 7, 8 & 9** of this notification. As per para **13) III (k)** of the notification, "Certificates in language other than English or Hindi should be accompanied by an attested translation in English/Hindi.
 9. It has been observed that some candidates have either not submitted proper documents/certificates issued by University or have some discrepancy in the uploaded documents/certificates. Accordingly, candidates who have been rejected with **Rejection Code-6** are hereby requested to resubmit their documents/certificates in compliance with **Para 13) III (c)** of this notification. As per para **13) III (k)** of the notification, "Certificates in language other than English or Hindi should be accompanied by an attested translation in English/Hindi.
 10. It has been observed that some candidates have either not submitted proper EWS/OBC & SC/ST documents/certificates or have some discrepancy in the uploaded documents/certificates. Accordingly, candidates who have been rejected with **Rejection Code-8 & 11** are hereby requested to resubmit their documents/certificates in compliance with **Annexure – IV (for EWS), Annexure – II (for OBC) & Annexure – I (for SC/ST)** of this notification. As per para **13) III (k)** of the notification, "Certificates in language other than English or Hindi should be accompanied by an attested translation in English/Hindi.
 11. Certain discrepancies have been observed in the names and other entries across certificates and application forms, such as spelling or spacing errors, variations in the sequence of name and surname, inclusion or omission of the father's name or title, and inconsistencies in the father's name in different documents, under **Rejection Code – 10**. All concerned applicants are, therefore, advised to submit a proper affidavit duly sworn before a **1st Class Judicial/Executive Magistrate** to clarify such discrepancies and avoid rejection of their applications.
 12. It has come to notice that certain candidates have failed to submit the affidavit prescribed in **Annexure-V** of the notification. Consequently, candidates rejected under **Rejection Code-12** are hereby directed to resubmit the requisite affidavit. Applicants are further advised to furnish a properly executed affidavit sworn before a **1st Class Judicial Magistrate, Executive Magistrate, or a Notary Public**, as applicable.

- 13. All rejected and provisionally eligible candidates (with remarks) are hereby instructed to resubmit their documents as per the guidelines mentioned below:**
