

## **IMPORTANT NOTICE**

### **Scouts & Guides Quota (Open Advertisement) Recruitment.** **Notification No: RRC/ER/ Scouts & Guides Quota /2025-2026 (Open Advertisement)**

- **Scrutiny** of online applications received against the Scouts & Guides Quota (Open Advt.)/ 2025-26 recruitment for **Erstwhile Group ‘D’ (Level-1)** and **Group ‘C’ (Level-2)** has been completed in accordance with existing rules and guidelines.
- Status-wise lists of all applications have been compiled and enclosed as **Annexure-A to Annexure-D** for Erstwhile Group ‘D’ (Level-1) and as **Annexure-E to Annexure-G** for Group ‘C’ (Level-2).
- All applicants are advised to carefully check the status of their applications as indicated in the enclosed annexures and take necessary action as per the given instructions.
- **The following lists in accordance with the scrutiny report are provided in the order given below:**
  - a) **Rejection Criteria of Erstwhile Group ‘D’ (Level-1)** with rejection codes.
  - b) **Annexure-A:** List of 69 Rejected Applicants of Erstwhile Group ‘D’ (Level-1). All these 69 applicants need to upload required documents as per rejection codes and remarks.

- All **Rejected and Provisionally Eligible applicants (with remarks)** are being given a second and final opportunity to resubmit Additional/Missing documents. Rejected applicants are required to resubmit their documents as per their respective Rejection Codes and Remarks. Provisionally Eligible applicants (with remarks) must resubmit their documents as per their respective Remarks, while Provisionally Eligible applicants (without remarks) need not submit any documents.
- All applicants must strictly comply with the guidelines laid down in Notification No. RRC/ER/Scouts & Guides Quota/2025-2026 (Open Advertisement).

- As per Para 13(ii) of the Notification, applications of applicants who has submitted more than one application for the same post (Annexure-D) have been declared invalid and candidature has been cancelled.
- As per Para 11(iii)(k) of the Notification, certificates issued in languages other than English/Hindi must be accompanied by an attested translation in English or Hindi. Applicants who have submitted documents in any other language are hereby instructed to resubmit the same along with an attested English/Hindi translation, failing which their candidature is liable to be rejected.
- Certain discrepancies have been observed in the ***Certificate of Activeness*** (Annexure-VIII) submitted by several candidates such as incorrect format, not signed by an **Authorised Signatory**, omission of the names of Authorised Signatory, unclear or illegible rubber stamps etc. All concerned applicants are therefore advised to submit a proper Certificate of Activeness strictly as per Annexure-VIII to avoid rejection.
- Additionally, certain discrepancies have been observed in the names and other entries across certificates and application forms such as spelling/spacing errors, variations in the sequence of name and surname, inclusion or omission of the father's name or title, and variations in the father's name in different documents etc. All concerned applicants are therefore advised to submit a proper affidavit duly sworn before a **1<sup>st</sup> Class Judicial Magistrate** to clarify such discrepancies and avoid rejection of applications.
- **Kindly Follow these guidelines to resubmit the documents:**
  - i) Check rejection code and the remark showing cause of rejection carefully and act accordingly.
  - ii) Applicants must ensure that the required documents are clearly visible and duly self-attested.
  - iii) Merge all separate documents into a single PDF.
  - iv) Upload the single PDF through the link <https://rrceronline.co.in/rejectionVo1/>
- Starting date for re-submission of documents is 14/10/2025 at 11:00 Hrs. and last date is 19/10/2025 at 18:00 Hrs. No submission will be entertained after the above-mentioned date and time.
- All provisionally eligible applicants may note that if their documents are found faulty or inadequate at any stage of the recruitment process, their candidature may be liable to be cancelled without any further notice.
- Simply being declared provisionally eligible does not give any right to appointment.
- All applicants are advised to regularly check their registered E-mail ID for updates and further communication.
- While every care has been taken in preparing the lists, RRC reserves the right to rectify any inadvertent error or typographical/printing mistake etc.
