For Junior Clerk cum Typist

- A) The result for Typing Skill Test (TST) candidates for the post of Junior Clerk cum Typist in
 - connection with GDCE 01/2019 is attached herewith as **Annexure A (for qualified)** and **Annexure**
 - B(for not qualified) in alphabetical order. The result status of the candidates has been indicated although it is of qualifying in nature . The standard of speed is decided in terms of RBE 19/2011

which was enclosed vide notice no. (86) dated 01.04.2022. Out of 1067 eligible candidates, 840

candidates appeared in the TST. Qualified candidates must note that passing in the TST does not

confer any right to come in the zone of consideration for DV, as TST is of qualifying nature.

Candidates are being called for DV in the ratio of 1:1 of notified vacancy as per merit of CBT,

among the TST qualified and also TST exempted PwBD candidates, who have appealed for

exemption before the stipulated date alongwith PwBD certificate issued by proper authority in

prescribed format. As per laid down instruction in Notice No.(86) dated 01.04.2022. The candidature

is purely provisional for DV called candidates. It is pertinent to mention that, the "TST absentee"

candidates as well as "not qualified" candidates have not been considered for making DV merit as

qualifying the TST stage was essential for next stage of recruitment process and candidature of such

candidates stands cancelled.

B) List of PwBD candidates who were exempted from TST after they submitted the required

certification in the prescribed format is attached (in alphabetical order) in Annexure-C.

C) It is pertinent to mention that vide Notice No.(93) dated 12.04.2022, a list of candidates was

published at Annexure-A, who have appeared in DV of Commercial Clerk cum Ticket Clerk but

their medical report was not final. Such candidates were given opportunity to appear for TST for the

post of Junior Clerk cum Typist. It is gathered from T&C Section/Hq that all such enlisted

candidates have been declared fit in prescribed medical category for the post of Commercial Clerk

cum Ticket Clerk and most of them have already joined as Commercial Clerk cum Ticket Clerk.

Hence, as per option given/submitted by these candidates at the time of DV for the post of

Commercial Clerk cum Ticket Clerk, they have not been considered for DV for the post of Junior

Clerk cum Typist.

D) The list of DV eligible candidates is attached herewith as **Annexure - D**, wherein status of each

candidate is mentioned. It is informed that DV for Junior clerk cum Typist will be held at a short

notice. DV eligible candidates should keep themselves in readiness with all the proper documents,

such as educational certificates, mark sheets, admit cards, PwBD certificate(as applicable), Caste

Certificate(as applicable and should be in Central Government List), Call letter of CBT, Call letter of

TST, sparing letter issued by controlling officer for CBT and TST, railway identity card, Aadhaar

card, 8 copies of photo as used in online application, etc., both in original and photocopy of the

same. Positive report is mandatory for the DV called candidates and further process. For the

candidates whose biometric report will be negative, for them DV would not be permitted on the

scheduled date. However, later such cases would be referred for forensic check through government

authorized experts. Their candidature will be decided on the basis of forensic report and

decision taken by Chairperson RRC on the basis of facts, rules. and instruction will be intimated

shortly on the notice board of RRC-ER website. Candidates will be intimated separately through

web notice on official website of RRC-ER. It is to note that, biometric verification will be done on the

day of DV with the records of CBT as well as TST. Candidates are instructed to keep checking the

website of RRC-ER regularly for any further instructions.

E) Instructions for appearing in DV of Junior Clerk cum Typist(GDCE-01/2019) has been uploaded.

Candidates are requested to go through thr instructions in detail and submit documents in the

prescribed format which was attached in the GDCE-01/2019 notification.
