NOTICE

Those CBT qualified candidates of GDCE No.01/2019 who have opted for the post of Junior Clerk cum Typist in the online application form, are hereby informed that the Typing Skill Test (TST) which is a qualifying stage for the GDCE for the post of Junior Clerk cum Typist is tentatively scheduled on **22.04.2022**. The eligible candidates for this stage are called in the ratio of 1:8 as per Railway Board letter No. 2013/E(RRB)/25/23 dated 08.10.2013.

The list of such eligible candidates for TST is attached as **Annexure - 1** as per their unit and application no. The candidates should keep themselves in readiness for appearing in the TST for which detailed instructions will be uploaded on the website of RRC ER.

Candidates who are already placed in the select list of Commercial Clerk cum Ticket Clerk and have cleared medical examination of the prescribed standard for the post of Commercial Clerk cum Ticket Clerk would not be eligible for TST. However, in case of administrative decision, such candidates will be allowed to appear for TST, in **addition** to TST call of candidates in the ratio of 1:8 of notified vacancy.

Final DV of Commercial Clerk cum Ticket Clerk will be held on 04.04.2022 as per RRC-ER notice and further processing of their candidature of the candidates as mentioned in RRC-ER Notice No. RRC/ER/GDCE/01/2019(85) dated 28.03.2022. The said candidates will be given an opportunity to contact RRC-ER by mail to rrcerkolkata2022@gmail.com for appearing in TST, if their medical status for the post of Commercial Clerk cum Ticket Clerk is not clear by **13.04.2022**.

Candidates of GDCE 01/2019, who have not opted for the post of Junior Clerk cum Typist while filing their online application against GDCE No.01/2019, are not eligible to appear in the Typing Skill Test (TST) as per GDCE Notification (01/2019) Para 5 which says - NON-ELIGIBILITY: vi. If an employee opts for ONLY one post out of the two available posts, his/her candidature would not be considered for the post not opted.

Following candidates who were called for DV for the post of Commercial Clerk cum Ticket Clerk, but have not opted for the post of Junior Clerk cum Typist.

Following **PwBD** candidates, who are eligible to come in the zone of consideration for TST are to appear for TST if they are unable to submit certificate as mentioned in para D of RRC-ER Notice No.RRC/ER/GDCE/01/2019(52) dated 17.09.2021 on the RRC-ER notice board, where in as per laid down provisions, PwBD candidates are **ONLY** exempted from TST if they are found otherwise qualified and are certified as being unable to type by the Medical Board attached to the Special Employment Exchange or by a Civil Surgeon where such a Board does not exists.

The duration of test will be TEN (10) minutes. If a Candidate does not qualify in above mentioned typing speed, then he/she will be considered unsuccessful in Typing Skill Test and he/she will not be considered further whatever be the marks obtained by him/her in the Final Written Test. The detailed schedule and instructions of TST will be posted after confirmation from concerned agency.

Further, to above, it is mentioned that no supplementary TST will be conducted other than due to administrative exigencies and candidates are advised to keep tracking the notice board of RRC-ER for further directions and information.
