Sports Quota (Open Advertisement) Recruitment. **Notification No. RRC/ER/Sports Quota/(Open Advertisement)/ 2025-26**

Online applications were invited from eligible applicants vide Notification No. RRC/ER/Sports Quota/(Open Advertisement)/2025-26, dated 03/09/2025, for recruitment under Sports Quota (Open Advt.) against various sports disciplines.

1. First Scrutiny of Applications

The documents uploaded by the applicants along with their online applications were scrutinized by the Scrutiny Committee. Based on the observations and remarks of the Scrutiny Committee, lists of **Provisionally Eligible** and **Rejected** applicants for the notified sports disciplines were published vide Notice No. RRC/ER/Sports Quota/(Open Advt.)/2025-26/(412), dated 03/12/2025.

2. Opportunity for Submission of Additional / Correct Documents

Subsequently, vide Notice dated 03/12/2025, a **second and final opportunity** was provided to applicants who were marked as **Rejected** or **Provisionally Eligible (with remarks)** to submit additional/correct documents, as per the respective rejection codes/remarks, through the link available on the official website of RRC/ER.
