List of Candidates not eligible for the Computer Based Aptitude Test (CBAT) for the post of ALP in Level-02 against 50% quota.

1. Based on the performance in the Computer Based Test (CBT) for the post of ALP conducted on **19.09.2024** and the medical examinations conducted by 07 units of Eastern Railway, lists of candidates found **not eligible** for Computer Based Aptitude Test (CBAT) / Psychometric Test and will **not be permitted** to appear for the CBAT are attached herewith as **Annexure-A**.
2. Candidates who have secured the minimum passing marks for the said CBT i.e. **60%** of the full marks with no relaxation for SC/ST [para 4.6 of notification no. ER/CBT/01/2024(RUNNING) dated 22/05/2024] and were found **unfit in A-1** medical category [as per the notification no.
