PROVISIONAL PART PANEL AGAINST RRC CEN-01/2019 FOR RECRUITMENT TO LEVEL-1 POSTS UNDER THE 7TH CPC

Against the 10,868 vacancies notified under Centralised Employment Notice (CEN) No. 01/2019 for Eastern Railway, Metro Railway and Chittaranjan Locomotive Works (CLW), the Provisional Part Panel comprising **60 candidates** for recruitment to Level-1 posts under the 7th Central Pay Commission (CPC) Pay Matrix is appended herewith.

This panel is purely provisional and does not confer any right upon any candidate to appointment in the Railways. The candidature of the empanelled candidate is subject to verification of certificates and other relevant documents by the concerned Railway Unit, which will issue the individual offer of appointment.

The allotment of posts has been made based on merit, medical fitness, availability of vacancies at the time of post allotment, and the options exercised by the candidates in their online applications, subject to fulfilment of all eligibility conditions prescribed in the notification and successful biometric verification. Allocation of Division/Unit will be made by the concerned Zonal Railway/Production Unit. Final appointment shall be subject to successful verification of all relevant certificates and documents, including caste, educational, and other requisite certificates.

The decision of RRC/Eastern Railway in all matters relating to this recruitment shall be final. This is only a **Provisional Part Panel** and **not the Final Panel**. Inclusion of a candidate's name in this panel does not confer any right to appointment in the Railway service. No individual correspondence or queries in this regard will be entertained by RRC.

The list of candidates who were called for Document Verification (DV) and subsequent medical examination but whose names do not appear in this panel will be uploaded separately, indicating the reasons for their non-inclusion or their revised status, as applicable.

The results of certain candidates have been kept pending and will be declared in due course, along with the reasons for their inclusion or non-inclusion in the panel.

All candidates who have been called or are being called for Document Verification (DV) from the 2nd DV to the 9th DV are hereby informed that all such Document Verifications have been conducted and are being conducted against those candidates who remained absent in the previous Document Verification(s), those who did not join the post after being empanelled, those who resigned or left the service within one year of their appointment, and those candidates who passed away within one year of their appointment (as per RBE 30/2022).

While every care has been taken in preparing this Provisional Part Panel, RRC/Eastern Railway reserves the right to amend, modify, or rectify the panel at any stage. If any discrepancy, malpractice, or irregularity is detected or brought to the notice of RRC at any stage, RRC/Eastern Railway reserves the right to rectify any inadvertent error or typographical/printing mistake and to declare any candidate unsuccessful or remove the candidate's name from the panel, as deemed appropriate.
