**Regarding 8th Round of Document Verification for Recruitment to Various Posts
of Level-1 against CEN RRC 01/2019**

Physical Efficiency Test (PET) for Level-1 posts notified against CEN RRC 01/2019 was conducted from 30/01/2023 to 10/02/2023. After the PET up to 7th round of document verification has been done.

Category and community-wise cut-off marks (for the 8th round of DV) are uploaded herewith as Annexure – “A”. Among the PET-qualified Non-PwBD candidates and among the PET-exempted candidates, lists of 8th round DV-eligible candidates, drawn as per merit and date, slot & DV venue is mentioned below in Annexure- “B”.

The tentative schedule of DV is 07.05.2026, 08.05.2026, 11.05.2026 and 12.05.2026. On the very next working day, DV-cleared candidates will be sent for medical examination. The call letter for Document Verification for SC/ST candidates will be sent to their email ids (3-4 days prior) and for other candidates it will be distributed at the time of DV.

Important Instructions (candidates must follow all the below mentioned instructions):

1. Candidates are strictly advised that entry for the 8th round of Document Verification will close at 09:00 hrs. No candidate will be permitted to attend document verification after the stipulated time under any circumstances. Candidates must strictly follow instructions of DV officials.

2. There are five stages of Document Verification:

- I. The **first stage** of document verification involves marking attendance through a **fingerprint biometric system**. Each candidate must record their presence using the biometric scanner, which ensures accurate and secure tracking of attendance.
- II. In the **second stage**, candidates are required to mark their attendance in a **manual form**. This form must include **two recent photographs with white background** of the candidate, which are attached for identification purposes and for official record-keeping.
- III. The **third stage** is the **entry of the identification mark**. Each candidate's unique identification mark is recorded to help verify their identity during the process. This ensures that all documents and records correspond to the correct individual.

- IV. During the **fourth stage, batch-wise document verification** takes place. Candidates are verified in their respective batches at assigned locations. All submitted documents are checked thoroughly to ensure they meet the required standards and authenticity.
- V. Finally, in the **fifth stage**, candidates are provided with the **pre-recruitment medical examination call letter and memos for medical fee, who have clear the document verification**. They are advised to carefully verify the details on the call letter, including their **name, roll number, and father's name**, before proceeding to the medical examination. This step ensures that all candidates receive accurate information for the next phase of the recruitment process.
3. No request for change of "Venue of Pre-Recruitment Medical Examination" will be entertained.
4. No candidate is allowed to leave the DV venue without the permission of RRC-ER officials. If any candidate is found missing during DV, their candidature will be liable to be cancelled, and no request for reconsideration will be entertained under any circumstances.
5. Candidates must bring a copy of the Application Form and the following certificates in original (along with two sets of photocopies of all documents duly self-attested):
- a. Mark Sheets and Certificates of all Educational/Technical qualifications mentioned in the Application Form/Notification.
 - b. Gazette Notification and/or any legal document in case of formal change of Name as mentioned in the Notification.
 - c. Certificate as proof of Date of Birth as mentioned in the Notification. In the absence of relevant Certificate/Proof of Date of Birth, candidature of the candidate will be cancelled (Birth Certificate will not be considered as valid documentary proof).
 - d. Caste Certificate for SC/ST (as per Annexure-I of Notification), OBC Candidates (as per Annexure-II of Notification) in prescribed format issued by the Competent Authority. OBC candidates are required to produce OBC Caste Certificate in prescribed format (not older than one year from the date of document verification) as well as valid OBC certificate at the time of application, which should clearly mention Non-Creamy Layer status (as per Annexure-IIA of Notification).
 - e. Income and Asset Certificate for Economically Weaker Section (EWS) (as per Annexure-III of Notification).
 - f. NOC from serving employees with Date of Appointment from the current employer.
 - g. Self-Declaration (as per Annexure-VII of Notification) and Discharge Certificate/NOC in case of Ex-Servicemen.
 - h. Disability Certificate in case of PwBD Candidates (as per V(A), V(B), V(C) of Notification).
 - i. Photo Identity Card as mentioned in CEN No. RRC-01/2019 (any one) and photocopy of both sides of Aadhaar Card with Original.

- j.** Receipt of Payment if made through a challan at SBI Branch or Pay-in-Slip at computerized Post Office.
 - k.** Income Certificate for waiving examination fee for Economically Backward Classes as per Annexure IIIA.
 - l.** Minority Community declaration on Non-Judicial Stamp Paper as per Annexure IV of Notification.
 - m.** Self-Certification by the Transgender Candidate.
 - n.** J&K domicile Certificate wherever applicable.
 - o.** Decree of Divorce/Judicial Separation from the Competent Court of law and Affidavit stating that the Candidate has not remarried, if applicable.
 - p.** In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not remarried.
 - q.** Candidate's portion of E-admit card of CBT &/or PET (as applicable).
 - r.** Candidates should ensure that all documents are valid, legible, and properly arranged to avoid delays.
- 6.** Candidates are also required to carry 12 copies of photographs with white background (size: 3 cm x 3.5 cm) similar to the scanned copy uploaded in the Online Application Form and 6 copies of latest photographs (size: 3 cm x 3.5 cm).
- 7.** Candidates must strictly abide by the instructions given by DV functionaries. Document Verification will be followed by Medical Examination only of those candidates who are found fit by the Screening Committee. Post-medical examination, pre-recruitment checking of documents may be done by units as deemed necessary.
- 8.** Requests for Change of Venue/Centre or Date of DV will not be entertained under any circumstances.
- 9.** Signature in the specified areas on the e-Admit Card and Attendance Sheet must tally with the signature of the candidate on the Online Application Form, CBT, and PET. Candidates must put their LTI/RTI in the specified space on the Attendance Sheet in presence of DV committee member/nominated person. Failure to comply may lead to rejection of candidature.
- 10.** Candidate must surrender RRC copy of the e-Admit Card of DV to the DV committee while retaining the candidate's portion.
- 11.** RRC/ER reserves the right to order cancellation in case of any candidate or a group of candidates, change of venue/date, or mode of DV.
- 12.** Furnishing any false information or deliberate suppression of required factual information, detection of which at any stage will render candidates liable for disqualification and debarment from appearing for DV, engagement, or appointment in Railways or any other government job.

13. In other matters, the terms and conditions laid down in the notice shall apply mutatis mutandis.
14. Any candidate found obstructing the conduct of the DV or creating disturbances at the DV venue shall be liable to cancellation of candidature and may be debarred from future Railway tests, with legal/criminal proceedings initiated. No re-DV will be conducted if disruption occurs due to instigation by candidates.
15. In case of walk-out, for any reason, NO re-DV will be conducted and the candidature will be cancelled immediately.
16. There shall be no claim for alternate appointment on the grounds of medical unfit, if any.
17. No representative will be allowed at the document verification venue, except for PwBD candidates. Candidates and accompanying persons are advised not to wait or remain at the main gate of the NKG Building (DV venue).
18. Candidates found eligible in Document Verification will be directed for pre-recruitment medical examination at the nominated Railway Hospital. Candidates shall make their own arrangements for stay for 3-4 days, if required, at their own expense. No TA/DA is admissible.
 - Candidates who have been cleared in the Document Verification (DV) stage are required to undergo a pre-recruitment medical examination at designated Railway hospitals. The medical examination memo and call letter will be issued to the DV cleared candidates by RRC-ER and these candidates will be sent to their respective Railway Hospital on the next working day after DV clearance. The memo will specify the hospital where the candidate must report for the examination. The designated hospitals are Kancharapara Railway Hospital (KPA), Sealdah Railway Hospital / BRS Hospital (SDAH), and Howrah Railway Orthopaedic Hospital (HWH).
 - Each candidate must obtain a **Rs. 24 medical fee memos** before reporting to the hospital. To do so, candidates should take their medical examination memo to the nearest Railway station of the respective hospital. At the ticket counter, they must present the memo, pay Rs. 24, and collect the receipt issued by the counter. This receipt is mandatory and must be produced at the hospital during the medical examination.
 - On the scheduled date of the medical examination, candidates must report to the hospital mentioned in their memo and carry all necessary documents, including the original medical call letter, the Rs. 24 receipt, and other required documents. Candidates should strictly follow the hospital's instructions and report on time.
 - Failure to produce the Rs. 24 receipt at the hospital may result in denial of the medical examination. Candidates are advised to retain copies of all documents and follow the procedure carefully to avoid any delays or complications.

- Absence on the scheduled date of the pre-recruitment medical examination will result in **cancellation of candidature with immediate effect**. No second chance will be provided under any circumstances, and **no requests or representations will be entertained**. Candidates are strongly advised to plan accordingly and ensure timely reporting.
- 19.** No second opportunity will be provided under any circumstances. Failure to appear on the scheduled date of Document Verification, including block dates fixed for absentees, or failure to produce valid and complete documents, will result in immediate cancellation of candidature.
- 20.** Railway shall not be responsible for any loss/damage caused to candidates during Document Verification.
- 21.** Merely being called for Document Verification does not confer any right for appointment; post allotment is dependent on clearing Document Verification and Medical Examination.
- 22.** All necessary care has been taken while preparing the list for eligible candidates, but inadvertent human errors cannot be ruled out. RRC/Eastern Railway reserves the right to correct such mistakes whenever noticed.
- 23.** Beware of touts and job racketeers attempting to deceive candidates with false promises. RRB/RRC never appoints agents or coaching centers. Candidates are selected purely on merit. Attempts to influence RRB/RRC directly or indirectly will lead to disqualification and possible legal action.
- 24.** Candidates are advised to visit only the official website of RRB/RRCs and beware of FAKE websites and social media content.
- 25.** Mobile phones, smartwatches, and electronic gadgets may be restricted inside the DV venue; candidates should follow instructions accordingly.
