Candidates, Provisionally Shortlisted for Stage-II along with Stage-II Schedule for Scouts & Guides Quota Recruitment (Open Advt.)/2025-26 for Erstwhile Group 'D' (Level-1)

Subsequent to the objection-raising process against the provisional Answer Key, review of the objections, and publication of the final Answer Key, and on the basis of performance in the Computer Based Test (CBT) of Written Examination (Stage-I) conducted by Railway Recruitment Cell, Eastern Railway on **28.01.2026** for recruitment against **Scouts & Guides Quota (Open Advertisement)/2025–26 for Erstwhile Group 'D' (Level-1)**, comprising 40 Multiple Choice Questions (MCQs) of 01 mark each and one Essay-type (Subjective) question carrying 20 marks, **the candidates bearing the Application Numbers mentioned at the end of this notice are provisionally shortlisted for Stage-II** of the recruitment process.

1. Components of Stage-II

Stage-II of the recruitment process shall comprise of:

- a) **Verification of Original Documents (Document Verification – DV).**
- b) **Marks on Scouts & Guides Certificates, and**

2. Documents Required for Verification

Candidates must produce the following **original documents** at the time of Stage-II:

- a) Proof of **Date of Birth (Age)**
- b) **Educational Qualification** certificates
- c) **Scouts & Guides Qualification** certificates
- d) **Community / Category certificates** and other claims, if any

3. Additional Requirements

Candidates must also bring:

- a) **One set of self-attested photocopies** of all the above certificates
- b) **Four (04) passport-size photographs** (same as submitted in online application)
- c) **At least One valid photo identity proof** issued by Government of India / State Government, such as:
 - Aadhaar Card
 - Voter ID Card
 - PAN Card
 - Driving Licence
 - Passport

Candidates are advised to ensure that all documents are complete and in order.

4. Validity of Certificates

- a) Certificates will be treated as valid **only if issued by Government-recognized Boards / Universities / Institutes**, strictly as per **Railway Recruitment Rules**.
- b) **The onus of producing valid and authentic documents** rests solely with the candidate.

5. Provisional Nature of Candidature

The candidature of all shortlisted candidates is **purely provisional** and subject to their being found **eligible in all respects** as per the terms and conditions of the Employment Notification

6. Cancellation of Candidature

If, at any stage of the recruitment process, it is found that a candidate **does not fulfil the prescribed eligibility conditions**, his/her candidature will be liable to be **cancelled forthwith without any notice**, and **no appeal** against such cancellation shall be entertained.

7. Stage-II Schedule (No Separate Call Letter)

- No separate call letter will be issued for Stage-II. This notice may be treated as an intimation to the candidates to appear for Stage-II of the recruitment process.
- Candidates are required to bring the **retained portion of the E-call letter of the CBT of Stage-I Examination** on the specified date, time, and venue of Stage-II examination.
- All **37 (Thirty-Seven)** candidates shortlisted for Stage-II may please note that Stage-II is scheduled to be held on **24/03/2026** and **25/03/2026**. All such candidates are required to remain present on both dates at **10:00 AM** at the venue mentioned below. Candidates are also advised to bring all required documents on both dates.
