IMPORTANT NOTICE FOR CANDIDATES GDCE Notification No.RRC/ER/GDCE/01/2019

(For posts of Junior Clerk cum Typist and Commercial Clerk cum Ticket Clerk)

- (A) The Railway employees of Eastern Railway, who applied against GDCE Notification No.RRC/ER/GDCE/01/2019 (Junior Clerk cum Typist and Commercial Clerk cum Ticket Clerk) are hereby informed that CBT for the above GDCE is scheduled to be held tentatively in 3rd week of October, 2021.
- (B) Due to objections raised by candidates and since lot of time has passed due to COVID pandemic, it is required to take a fresh look at the eligibility list, in order to minimize the grievances and also to accurately allot Test Centres to candidates, who have been transferred out.
- (C) This is for information that as per Rly Bd. Letter no. E(NG)II/2017/RC-2/1/Policy dated 27.2.2019, following PWBD categories are suitable for the notified posts.

(I) Commercial Clerk cum Ticket Clerk

(D) It is also stated that as per Railway Board's letter No.E(NG)II/2006/RC-2/13 dated 13/11/2019, due facilities to the PwBD candidates with benchmark disability are to be extended, though the same was not included in the GDCE notification. Candidates with benchmark disability will be given facility of scribe of their choice, compensatory time and exemption from typing test in terms of RBE 93/2014 and 62/2017, if they are made eligible for these relaxations against PwBD category by respective units. However, there is no reservation for PwBD candidates in GDCE in terms of RBE 65/2019 and 72/2019.

(E) In view of the above, the web notices dated 18/02/2020, 19/02/2020 and 06/03/2020, which was published on the official notice board of RRC/ER/Kolkata, should be treated as cancelled.

(F) The list of 7444 candidates is again being sent to respective units for checking and giving remarks of 'Eligible' or 'Not Eligible' as well as indicating PwBD. And after recheck, a final eligibility list will be issued, on the basis of data sent by units. The candidates, who were in the list of ineligible candidates/provisional eligible candidates, earlier or those who have objections, can contact their units immediately for remedy.

(G) The eligible candidates are alerted to be in readiness for the CBT, which will be held for 100 questions of 90 minutes duration and will be of the level of RRB examination as notified in para-10(viii) of the GDCE notification. They should also keep their registered mobile number and e-mail ID (as filled up in GDCE application form) functional. For rest of the information candidates should consult the notification and keep checking the notice board of website of RRC/ER/Kolkata.
